

Alumni Spotlight: Avery Friedman '72 Recognized with Southern Christian Leadership Conference's President's Award

The [Southern Christian Leadership Conference](#) recently recognized **Cleveland State University College of Law alumnus, Adjunct Professor and Hall of Fame member Avery Friedman '72** with its *President's Award*, the Conference's highest honor. Friedman received the honor for his decades of work championing the fight for equality as a civil rights attorney.

The Southern Christian Leadership Conference (SCLC) is a civil rights organization closely associated with its first president, Dr. Martin Luther King Jr. The SCLC's roots trace back to the Montgomery Bus Boycott of 1955-1956 sparked by Rosa Parks' arrest for refusing to give up her seat to a white man on the bus. The SCLC's mission is to bring about the promise of "one nation, under God, indivisible" together with the commitment to activate the "strength to love" within the community of humankind.

Friedman received the award at the [SCLC's Annual Convention](#) held in Washington D.C. The conference commemorated the 60th anniversary of the March on Washington and Dr. King's "I Have a Dream" speech.

"Receiving the highest award given by the Southern Christian Leadership Conference, the organization founded by Dr. King, was a truly incomparable experience," stated Friedman. "While I acknowledge that the backdrop of the time and event tells the general story, being personally surrounded by the well-wishing from hundreds of members of the clergy and celebrated civil rights leaders was as electrifying as it was humbling. Imagine being part of an event in the shadows of the Lincoln Memorial. I could not have understood until I got there that it was a lot bigger than I could have imagined."

Conference: War Crimes in Ukraine: The Abduction and Deportation of Children

This Conference will address the ongoing war in Ukraine with a particular focus on the war crime of abduction and deportation of Ukrainian children by the Russian authorities. Over the past year, Russian authorities have willfully separated Ukrainian children from their families and have orchestrated a policy whereby such children are adopted by Russian families. The Conference will focus on the ongoing International Criminal Court's investigation into the war crime of abducting and deporting children, as well as on other relevant international law issues related to imposing accountability on Russian President Vladimir Putin and Maria Lvova-Belova, Russian Commissioner for Children's Rights.
