Flexjet Chairman Kenneth C. Ricci '86 to Deliver 2024 CSUILAW Commencement Address

Kenneth C. "**Kenn**" **Ricci '86**, Chairman of Flexjet and Principal of Directional Aviation Capital, will deliver the commencement address at Cleveland State University College of Law's graduation ceremony for the Class of 2024. *The ceremony will take place Sunday, May 19, 2024 at 1:00 p.m. at the KeyBank State Theatre.*

"As our distinguished alumnus and a member of our CSU|LAW Hall of Fame, we are honored to have Kenn Ricci speak to our 2024 graduates," said **CSU|LAW Dean Lee Fisher**. "Kenn is an extraordinary leader and exemplifies how our graduates can use the

legal and leadership skills they developed throughout law school to forge a successful career path no matter where their interests lie."

For Ricci, his primary interest has always been aviation. His love of aviation has led Ricci to found, acquire, or finance a broad range of aviation companies and ideas over his career. He has assembled one of the largest groups of private aviation companies which together account for over four billion dollars of revenue, operate over 300 aircraft and employ over 5,000 individuals.

Ricci began his aviation career as an Air Force ROTC cadet at the University of Notre Dame and soon thereafter, started his first company, Corporate Wings. He is an airline transport pilot with extensive international experience and was Arkansas Governor **William Clinton's** pilot when he ran for President in 1992. Ricci is the founder of Nextant Aerospace, the innovator of Aircraft Remanufacturing.




"I have the privilege of being in a practice area where I continuously see individuals achieving big dreams, and it is exciting to witness," said Flannery.


