

**Remembering Dean and Professor Lizabeth Moody** It is with great sadness we learned Professor Lizabeth (Liz) Moody passed away in Florida on May 19, 2023. We send our sincerest condolences to her family and many friends. Professor Moody was an icon in legal education. The National Jurist once rated her as one of the 25 most important people in legal education. Her biography has been placed in the Library of Congress as one of the Women Trailblazers in the Law. Professor Moody was inducted in our CSU|LAW Hall of Fame in 2017. In 1967, she joined our adjunct faculty and in 1970, she joined our full-time faculty, and served as a member of our faculty for 20 years. She was the second woman member of our tenure track faculty, after Professor (and later Judge) Ann Aldrich. In 1987-88, she served as Interim Dean of CSUILAW, the first woman to hold that position. Professor Moody generously funded the The Lizabeth A. 
