- c. What can he do to be a better Dean? Q/A
  - i. Nina: Excited about everything Dean has been doing, i.e. presence around the school, engagement with student body; Q: Has his opinion changed about wanting to be permanent dean?
    - **1.** He tells story:
      - **a.** This position came suddenly and he was asked to consider being the Dean
      - **b.** He applied to be Dean 5 years ago and was a finalist.
      - **c.** He always wanted to be a Dean, but decided that since he didn't get the position, that it might not be for him anymore.
      - **d.** Became president and CEO for a consulting company; has travelled for the last 5 years around the world seeking ideas for how to make American cities better

  - 1. Single best way to be competitive is to find distinctive advantage
  - 2. He's stil learning but:
    - a. Loyal Fan Base: We have an unusually deep alumni network; doesn't think we leverage it for purposes of job placement...
    - b. Quality AND Opportunity, i.e. evening program
    - c. in the middle of a city that is going through a renaissance and is still affordable
    - d. we have to identify areas of curriculum
      - i. i.e. cyber security—shows that CM Law gets it and is predicting where the world is going (before other law schools)
  - 3. financially sustainable, have vision that others see, and ahead in our curriculum
