DID YOU KNOW?

Susan Becker has been serving on the Supreme Court of Ohio's Commission on Rules of Practice and Procedure for the past three years. The Commission is comprised of 19 judges, magistrates, and lawyers who represent various geographical and philosophical perspectives on the practice of law in this state and who are charged with reviewing and, where appropriate, recommending amendments to the Court for the Ohio Rules of Civil Procedure, Rules of Criminal Procedure, Rules of Evidence, Juvenile Rules, and other Ohio rules. Effective January 1, 2006, Susan was appointed Chair of the Commission's Civil Rule Committee, and is managing an ambitious docket of possible amendments to a number of Ohio's civil rules.

Dena Davis taught an intensive bioethics course in June that included Prof. Noam Zohar of Bar-Ilan University in Israel as co-teacher, and five Bar-Ilan students, as well as Cleveland-Marshall students. The topic was assisted reproductive technology. Dena also taught "International Biomedical Ethics" in our Russia program in St. Petersburg in July.

This last summer, **David Forte** attached the 25th Congress of the Pontifical Council for the Family at the Vatican (in which body he serves as Consultor). At the end of the Congress, he had an audience with Pope Benedict. He also gave a lecture on "The Tradition of Originalism in United States Constitutional Interpretation" to the graduate seminar on Comparative Constitutional Law at the University of Trento. In Amman, Jordan, under the auspices of the National Democratic Institute, he advised 40 Iraqi officials on possible amendments to the Iraqi constitution.

Kunal Parker is the holder of the prestigious NYU Golieb Fellowship in Legal History. Only three or four fellowships are awarded every year.
