

SPEAKING ENGAGEMENTS

Proposals submitted by **Susan Becker** and **April Cherry** have been accepted by the SALT Teaching Conference Committee. The Teaching Conference, co-sponsored by the Society of American Law Teachers and the Thelton E. Henderson Center for Social Justice at Boalt, will take place on March 14-15, 2008 at the University of California, Berkeley. The theme of the conference is *Teaching for Social Change*.

On October 29, **Phyllis Crocker** participated in a nation-wide press conference at the National Press Club in Washington D.C., that C-Span carried live. The purpose of the press conference was to present the combined results of the ABA death penalty studies completed in eight states.
