ELECTION DAY ACTIVITIES

Susan Becker worked from about 6 a.m. to 9 p.m. as a Democratic election observer at a polling place in the city of Lorain. She reported: "There were 7 precincts voting at this location and it was pretty busy throughout the day. I spent most of my time making sure that voters were not turned away or given provisional ballots if they were entitled to cast standard ballots, and also ascertaining that poll workers and other election officials were handling the machines and voting materials according to law. It was a great experience and an honor to participate in one of the most important elections in recent history."

Carolyn Broering-Jacobs acted as a poll observer at St. Paul Lutheran Church in Westlake. She was there all day (5:30 a.m. to 9:00 p.m.) with no breaks.

Mickey Davis wrote: "I spent election day, and the day before, calling voters for Moveon.org. I called about a hundred people in those days, mostly in Indiana and Ohio trying to get out the vote. The day before was mostly the dregs, that is, phones that simply hadn't answered in the days, weeks and months earlier to that since by Election Day most of the 'good' numbers have already been worked. On Election Day, however, most of the phones answered, and a good number of people had already voted. Our job was to encourage them to take friends and family with them since, being 'good' numbers we knew they would vote; the idea was to get them to take others who might not vote, and thus boost the results to whatever extent we could. I have done this since the Dean internet campaign converted field work into things that people like me with families and job responsibilities could do from the home or office."

Kathleen Engel tried to bring food and water to three different polling places, but there were no lines. She offers: "If any one needs a bottled water, come see me!"

Joan Flynn was a non-partisan observer for the Election Integrity project.

Candice Hoke, Director of CSU's Center for Election Integrity, was answering media calls throughout election day.

Dennis Keating canvassed, as he had previously, for Obama in the African-American Lee-Harvard neighborhood of Cleveland, immediately southwest of its border with Shaker Heights. His co-canvasser was an older African-American woman and her 10-year-old son. Dennis worked the 9:30 a.m.-1:00 p.m. shift.

Sandra Kerber was a member of the Coalition for Judge4Yourself. The Judicial Candidates Rating Coalition (or JCRC) interviewed Judicial Candidates and then prepared the Judge4Yourself information for the community at large. She reported: "The amount of work that goes into this endeavor offers a valuable service because of the extensive data that we receive regarding the qualifications of the candidates. The system is not perfect because the coalition has no control over the actual candidates."

Steve Lazarus reported: "On the afternoon of election day, Ellen flew back from Atlanta where she had been visiting our grandchildren. We had earlier volunteered as canvassers for the Obama campaign so dropped off her luggage at home and proceeded to the Shaker Square office where we performed our citizenship duties, ate heartily of the food contributed by many supporters (including Ellen), and met many energetic, committed and (ultimately) very happy people."

Claire Robinson May spent Election Day as a Democratic Party poll observer in Maple Heights. She reported: "It was important to be there because poll workers were not always clear on the proper procedures (voter I.D., provisional ballots, etc.). We had long lines in the morning and steady voter turnout the rest of the day."

Kevin O'Neill provided refreshments for poll workers at a precinct in Warrensville Heights, where his wife, Sonia Winner, worked for the Obama Campaign as a poll observer.

Heidi Gorovitz Robertson worked for the Cuyahoga County Board of Elections as a poll worker. Between polling location set-up on Monday night, November 3, and closing of the polls on Tuesday night, November 4, she spent 16 hours working at the polling place.

Chris Sagers was a poll worker for Cuyahoga County Democratic Party at a polling place in Slavic Village, Cleveland.

Steve Werber served as an Official Precinct Observer on Election Day in North Royalton.
