Cleveland-Marshall students Michael Ritz and Johanna Lopez taught the rising ninth graders and two students from Case Law School taught the rising tenth graders. **Inga Laurent**, was the on-site coordinator for the program. **Louise Dempsey** coordinated efforts with the Cleveland schools and oversaw the law firm internships. **Sandra English** recruited the judges for the two day mock trials and assisted with obtaining the daily speakers. Fifty Cleveland Metropolitan School District students participated in the Institute.

On July 15, **Browne Lewis** and **Janice Aitken** gave an interdisciplinary seminar to a undergraduate students participating in the McNair Scholars Program. The seminar focused on the relationship between STEM (Science, Technology, Engineering, or Mathematics) disciplines, administrative law governing workplace safety, and common law liability for injuries and damage arising out of STEM related activities. The participants in the McNair Scholars Program are undergraduate students from disadvantaged backgrounds who have demonstrated the capacity to excel in STEM or STEM-related disciplines. The McNair Scholars Program, sponsored by the United States Department of Education, is designed to prepare and encourage these students to pursue a Ph.D. in STEM or STEM-related disciplines.
