

On October 16th, **Mark Sundahl** delivered a paper entitled *Bigelow Aerospace's Commodity Jurisdiction Request under ITAR and its Impact on the Future of Human Spaceflight* at the 2009 Astronautical Congress in Daejeon, South Korea.

DID YOU KNOW?

Chris Sagers was asked to provide written testimony to the House Judiciary Committee on H.R. 3596, the Health Insurance Industry Antitrust Enforcement Act of 2009. The bill would repeal the current exemption from antitrust for insurance companies, as it applies to health and medical malpractice insurers.

Chris has also been named to the Advisory Board of the American Antitrust Institute, a non-profit think tank based in DC.

Karin Mika was a judge at the John Marshall Information, Technology, and Privacy Moot Court Competition in Chicago on October 3rd.

David Barnhizer has been appointed Visiting Professor to the University of Westminster. This is a three-year appointment for occasional visits to deliver and/or participate in lectures and seminars for staff and students, planning research, participating in international seminars, conferences and other events.

Michael Davis filed an amicus brief in the U.S. Supreme Court for Knowledge Ecology International (KEI), a public interest group devoted to increasing access to public information, especially with regard to health care and pharmaceuticals. The case, *Bilski*, concerns business method patents and revolves around the proper test the patent office should apply to prevent the patenting of mere ideas.
