

Brian Ray was invited to join the editorial board of the International Review of Constitutionalism.

Jonathan Witmer-Rich's article—*Corporate Complicity Claims: Why There is No Innocent Decision-Maker Exception to Imputing an Officer's Wrongdoing to a Bankrupt Corporation*, 74 Tenn. L. Rev. 59–80 (2006)—was cited favorably by the bankruptcy court for the S.D.N.Y. in the case of /ln re: The 1031 Tax Group/, Case 07-11448, slip op. at 36 (Bankr. S.D.N.Y. Dec. 3, 2009). Relying on the reasoning from the article, the court dismissed a complaint by a bankruptcy trustee seeking several hundred million dollars from Citigroup.

Candice Hoke met with policymakers in the Office of Legal Counsel, Executive Office of the President, regarding election cyber security issues. She also presented a paper on *Election Recounts* at the Election Verification Conference in Washington, D.C. in April.

Candice has met with the US DOJ Antitrust Division twice, and submitted comments and recommendations for amendments to the proposed Final Judgment regarding the merger and DOJ-ordered divestiture of the two largest voting equipment companies.

Candice drafted a resolution for the ABA Standing Committee on Election Law regarding voter registration modernization and improvement, which, after amendment, has been approved unanimously. It will be sent to the ABA House of Delegates for a vote in August.

Karin Mika published *Acknowledging Our Roots: Setting the Stage for the Legal Writing Institute* in the spring 2010 edition of THE SECOND DRAFT, a yearly publication by the Legal Writing Institute that includes articles of interest to skills teachers.

Karin was a grader for the Hardy C. Dillard Memorial Competition, a new competition sponsored by ILSA in which the "best of the best" Jessup briefs (the regional winners) are re-evaluated for a separate award.

Karin was selected for the poster subcommittee of the LWI/ALWD scholarship committee. Her job is to conceptualize a poster for the LWI annual conference that explains and celebrates what the scholarship committee does.

C|M|LAW student Daniel Myers was quoted in a May 2 issue of The Plain Dealer in an article by Rachel Dissell, regarding his participation in a demonstration at Cleveland City Hall demanding that the city tell its citizens how many untested sexual assault examination kits or "rape kits" the city has on hand. Rape kits provide evidence collected from a victim that can lead to the apprehension and prosecution of an attacker. The protesters, an alliance of students and faculty from CSU and CWRU were responding to an earlier story in which the PD requested that the city divulge the number of kits it has on hand.
