On October 12, **Kevin O'Neill** spoke to a Democratic Party organization in Cleveland on several First Amendment topics: (1) the U.S. Supreme Court's *Citizens United* decision and its connection to the current flood of political advertisements; (2) a July 2010 decision by the U.S. Court of Appeals for the Sixth Circuit striking down Kentucky's ban on certain statements by judicial candidates (statements identifying the candidate's political party affiliation and statements soliciting campaign contributions); and (3) August 2010 amendments by the Ohio Supreme Court to the rules governing statements by judicial candidates in Ohio, bringing Ohio's rules into conformity with the Sixth Circuit's ruling.
