

2024-2025 Sample Curriculum & Tuition JD Online Program

The study of law is demanding as it is designed to prepare you for a professional career. The CSU Law Online JD program requires 90 credits. Courses are taught in a blend of asynchronous and synchronous formats. Live class sessions generally are scheduled from 6:00pm to 9:00pm Monday through Thursday (Eastern Time). The number of days each week live class sessions occur varies with the course and section. Students following the sequence below may have up to three live course sessions each week during the first two years. Elective courses may meet more often. Below is a sample curriculum and estimated tuition based on Academic Year 2024-2025 rates.
