



## Student Profile: Global Space Law Research Council's Kristina Schiavone

Cleveland-Marshall 3LE Student **Kristina Schiavone** graduated from the College of Wooster with a degree in chemistry and has worked as an associate chemist for the past four years at Coventya, Inc., a company that specializes in producing metal surface treatment chemicals. She had been considering going back to school to pursue a Ph.D., but when she started to see all the regulations affecting her work, she realized the far-reaching influence lawyers and lawmakers have even in the chemical industry. Having been intrigued by law school previously, she decided she would have the greatest impact in her career by studying the law.

Schiavone is now a student member of the Global Space Law Center Research Council. One of Schiavone's main projects with the Council has been planning the Center's **Annual Symposium, *Returning to The Moon: Legal Challenges as Humanity Begins to Settle the Solar System***. Schiavone has facilitated securing high-profile speakers from NASA, SpaceX, U.S. Department of Commerce and other companies and organizations.

The March 6 symposium will begin with an overview of space law and how far the discipline has progressed to date. Schiavone believes it will be interesting and informative for casual observers who are new to the field as well as those already involved in the space law sector. She notes that the moon and its regulation is a particularly important topic because it will likely set a precedent for the regulation of Mars as well as other planets and discoveries in space.

"The world is ready to again take on the exploration of outer space," said Schiavone. "The more informed you are, the more you will understand what the future holds."

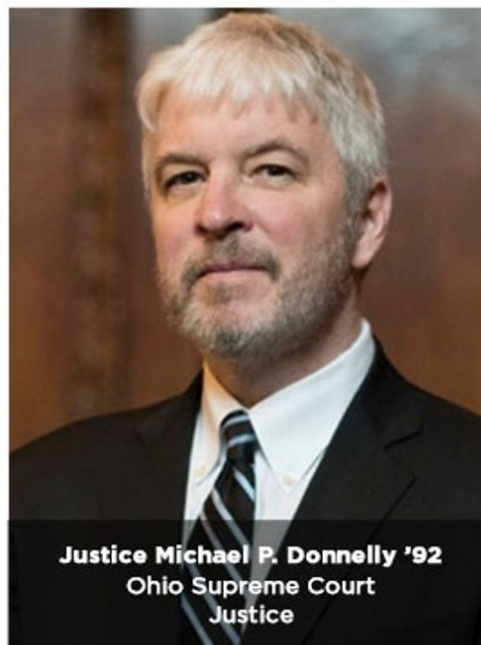
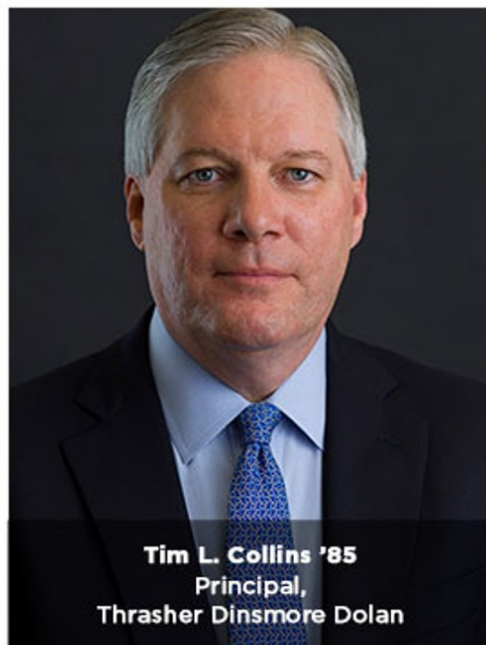
