In close consultation with faculty, staff, health officials, Governor DeWine's office and our trustees, we have made the decision to extend Spring Break another week and to shift classes to remote delivery and cancel on-campus classes when classes resume on March 23. We will deliver

classes in this way through April 10 with the intent to resume on-campus classes on April 13, although we will continue to reassess this approach. Even though oncampus classes will be cancelled, the university will remain open.

CSU C|M|LAW Hall of Fame Profile: U.S. District Court Judge Solomon Oliver Jr.


United States District Court Judge for the Northern District of Ohio and former CSU Cleveland-Marshall College of Law Professor and Associate Dean Solomon Oliver Jr., a member of the CSU C|M|LAW Hall of Fame, has received numerous awards recognizing his distinguished career. Most recently, Judge Oliver was honored by the Cleveland Metropolitan Bar Foundation for his civic service with its 2020 Richard W. Pogue Award for Excellence in Community Leadership and Engagement.

Receiving recognition for his work has never been a goal for Judge Oliver, who has served on the federal court since 1994 when he was appointed by President Bill

Clinton. He is humbled when considering those who have been previously recognized with the award and the work of so many other people who could have been recognized. His renowned career includes having overseen Cleveland's 2015 consent decree with the federal government to change the Cleveland Division of Police policies on search-and-seizure and use of force, which could not have seemed possible to Judge Oliver when growing up as one of 10 siblings in Bessemer, Alabama.

Judge Oliver was raised in the deep South in the 1950s and 1960s at a time when segregation was in full force. Despite his upbringing in a society that severely restricted opportunities for African Americans, his family never expressed negative connotations toward any other group of people. While firmly believing in the principles America stood for - the principles embedded in the Declaration of Independence and the Constitution - they were keenly aware that these principles would not become a reality for African Americans without a struggle.




