#### **Criminal Justice Forum: Reflections of an International Criminal Prosecutor**



The Honorable Fatou Bensouda, former **Chief Prosecutor of the International Criminal Court** 

Fatou Bensouda served as Chief Prosecutor at the International Criminal Court (ICC) from 2012-2021. Before that, she served as Deputy Chief Prosecutor at the ICC and as Prosecutor at the Rwanda tribunal.

Prosecutor Bensouda will discuss relevant international criminal law issues related to the

prosecution of leaders who order the commission of atrocity crimes. In addition, she will discuss challenges and opportunities associated with such prosecutions, and with leading prosecutions at an international tribunal.

Between 1987 and 2000, Ms. Bensouda served in successively senior positions in The Gambia, including Attorney General and Minister of Justice, in which capacity she served as Chief Legal Advisor to the President and Cabinet. In March 2022, Ambassador Bensouda was appointed by the UN Human Rights Council to be Chairman of the threeperson International Commission of Human Rights Experts on Ethiopia which is investigating atrocities in Tigray and neighboring regions.

#### **Criminal Justice Forum: Ruined: Language Use** and Choice By Judges at Sentencing in Rape and Sexual Assault Cases

Judges play a critical role in one of the most important states of a criminal case's adjudication—sentencing. While there have been substantial limitations placed on the discretion judges can exercise in devising punishments, there are little to none on what judges say at such hearings when articulating their rationales for the sentences they impose on convicted defendants. In her lecture, Professor Romero will examine the language judges use when sentencing defendants convicted rape, sexual assault, and sexual abuse that describes victims of those crimes and the harms they have sustained, especially language that describes victims as "ruined," "broken," or "destroyed." Professor Romero argues that the use of such language, while apparently meant to be empathetic, only serves to uphold misogynistic understandings of rape and sexual assault and actively harms victims. Judges trying to justify harsh sentences for defendants convicted of sex crimes also engage in shaming and exploitation of victims when saying that defendants have left victims "ruined" at sentencing.
